

Miasms

The June 11 issue dealt with the §189, §5 & §81 which explained how Genetics is the base of Homoeopathic science. In continuation with that, we will see other processes going on at the genetic core and their genetic expressions - **Miasms**.

The most controversial topic till date in the history of homoeopathic science is **Miasm**. Stalwarts of homoeopathy had differences of opinion on Miasms.

Dr. Hering said, "I don't believe in the theory of chronic diseases of Dr. Hahnemann. He taught me 'Aude sapere-dare to be wise. Don't follow anyone blindly', then how can I follow Hahnemann blindly. 'Law of similia' is above all . If the remedy is most similar, it has to act . All the rest is just theory."

Dr. Boger said, **"if the constitutional remedy is right, it has to cover that miasm. There is no need** of intercurrent."

Students of Homoeopathy are confused when they read these comments of masters of yesteryears. They get more confused when they read about newer and newer miasms formed by the contemporary masters, some discarding the whole miasm theory.

We have to remember that **Dr. Hahnemann had described his discovery of Miasm the most important discovery than the law of similia**. Then why so much of confusion regarding Miasm? Every Homoeopath came up with his own theories, his own assumptions. Dr. Hahnemann was aware about the fact that no one will understand his theory of chronic diseases. He mentions in Theory of chronic diseases "but in communicating to the world this great discovery I am sorry that I must doubt whether my contemporaries will comprehend the logical sequence of these teachings of mine and will follow them carefully and gain thereby the infinite benefits for the suffering humanity which must inevitably spring from faithful and accurate observance of the sameor whether frightened away by the unheard of nature of many of these disclosures, they will not rather leave them untried and uninitiated and therefore, useless."

It is **Dr. Vijayakar** who simplified the most complicated topic miasm by explaining aphorism 74 on the basis of the pathological processes of defenses at the cellular level and put an end to all assumptions to the miasms in his book **'end of myasumptions'**.



Materia Medica

In this issue, we will cover the remedy Arsenic Album- a very useful and deep acting polychrest remedy of our Materia Medica.

We try and see here, how the Arsenic personality would present to us in the 3 different miasms-Psora, Sycosis and Syphilis.

In this topic we will also see the relevant rubrics of the remedy as we study the drug picture and also what our great masters like Dr Kent, Dr Hering, Dr Clarke and Dr Phatak have mentioned in their books regarding this remedy.

The rubrics and the materia medica from the master's works are mentioned in bold below for your easy reference.

The rubrics are mentioned either in capital, small or italics depending on their grading in the repertory.

A rubric which is exclusive to the remedy is mentioned as UNIQUE.

ARSENICUM ALBUM

Dr Clarke mentions in his writings that "Arsenic is the horse's remedy; as Pulsatilla is the sheep's and Antim.crud. the pig's. The reprehensible fashion of "doctoring" horses with Arsenic is merely an abuse of a therapeutic fact. The horse is an animal on whose power of endurance and "wind" enormous demands are made, and Arsenic is the remedy for the effects of feats of prolonged endurance. The Arsenic habit of the Styrian mountaineers has arisen from the discovery of its power of strengthening the muscles both of the limbs and of the breathing apparatus."

But in another way the horse typifies the Arsenic temperament. The mental symptoms of any drug, when pronounced, carry precedence of all others. The horse is an exceedingly nervous animal, constantly moving about, restless to a degree, and very prone to take fright - quite a picture of the Arsenic temperament.

Dr Hering describes Arsenic as 'The Gold Headed Cane' patient.

The gold headed cane patient that Hering describes refers to the gracefulness in Arsenic. It is a remedy like Ignatia, which is very polished and graceful. The grace can be seen from the way they talk, walk and even dress. They are sober-well dressed individuals who are polite in their behavior and way of talking. They are compared to the grace of a swan. They draw attention of others by the way they look.

They are individuals who are affected by anger, fright and anticipation. The anticipation in Arsenic is its hallmark symptom. The anticipatory nature comes forth when they have to attend a meeting or event.

Eye
